



Mississippi Junior Golf Association 2020 Membership



Eligibility: Membership is open to boys and girls through the summer immediately following graduation from high school or their 19th birthday, whichever comes first. Players must be bona fide residents of the state of Mississippi and MJGA members to be eligible to compete in MJGA Events and the MS Boys and Girls Junior Amateur.

Information/Age Groups: **Boys Division A 16 – 18** year olds, **Division B 14 – 15** year olds: these groups will play 18 holes from a tee measuring 6,400 – 7,000 yards in total course length. **Division C 12 – 13** year olds will play 18 holes from a tee measuring 5,600 to 6,200 yards in total course length. **Division D 10 – 11** year olds will play 9 holes from a tee measuring 2,400 to 2,800 yards. **Division E 9 & under** will play 9 holes from 100 – 300 yards per hole and may have a caddie. **Girls Division A 16-18** year olds, **Division B 13-15** year olds: will play 18 holes from a tee measuring 5,600 – 6,200 yards in total course length. **Girls Division D 10 – 12** year olds will play 9 holes from a tee measuring 2,400 – 2,800 yards in total course length. **Girls Division E** will play 9 holes measuring 100 – 300 yards per hole. A player may play up one age group if they desire. *This must be indicated when entering.*

The age you will be on June 1, 2019 will be the age division you participate in for the 2020 season.

Points: Points are awarded to players of each division toward male and female Player of the Year, Junior Pro Am, and Junior Cup Teams. Points are awarded at MJGA events and MJGA Sanctioned events. To view the point's breakdown, visit www.missgolf.org.

I am qualified by the rules of eligibility and I agree to abide by the rules and regulations of the Mississippi Junior Golf Association. My membership fee is enclosed and I understand this membership is non-refundable once I have been accepted as a member of the MJGA. I understand that photos taken by the MJGA or any person employed by the MJGA may be used for promotions, displays or advertisements. As the parents or guardians of the applicant, I hereby certify the facts on this membership form and state that I am familiar with the applicant's plan to participate in these events and the applicant does so with my approval. Furthermore, I for myself and the applicant, hereby release the host facility its members, officers, employees, and the MJGA, its officers and employees, from any liability for any event or consequence whatsoever in any way arising out of or relating to the applicant's entry or participation in this tournament with the sole and singular exception of liability arising out of bad faith or willful misconduct. In case of emergency occurring during MJGA Events, I authorize a qualified medical doctor to take all necessary measures to treat the applicant. The policy of the MJGA is the use of spikeless/non-metal golf shoes only. The use of spikeless/non-metal golf shoes may result in the participant slipping on wet or damp surfaces and reduced traction of non-level areas of the golf course. As evidenced by the participant's signature on this entry the participant acknowledges that potential dangers relative to the use of spikeless/non-metal golf shoes have been disclosed to the participant and the participant agrees to assume the risk of sustaining an injury arising from or attributable to the use of spikeless/non-metal golf shoes at the Host Facilities' premises. The participant here releases the MJGA and MGA officers, directors, members, employees, successor and assigns (the "Indemnified Parties") from any and all claims for loss or damage of but not limited to personal injury, whether or not caused by participant's use of spikeless/non-spikeless golf shoes at the Host Facilities' premises in connection with the tournament. The consideration for this release is the permission granted by the MJGA to the participant in the golf tournament. This release binds not only the participant, but also the participant's spouse, heirs, legal representative and assigns.
